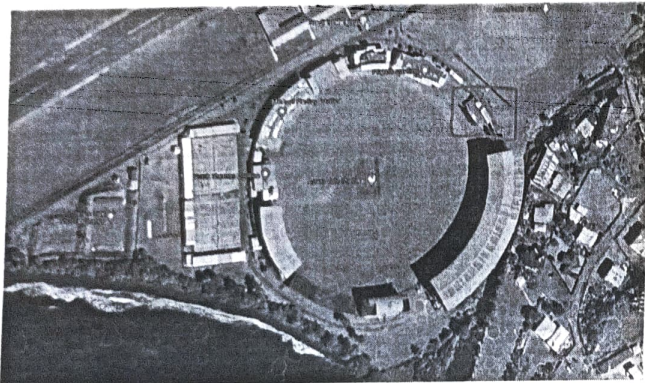

1. Technical specifications for the replay screen

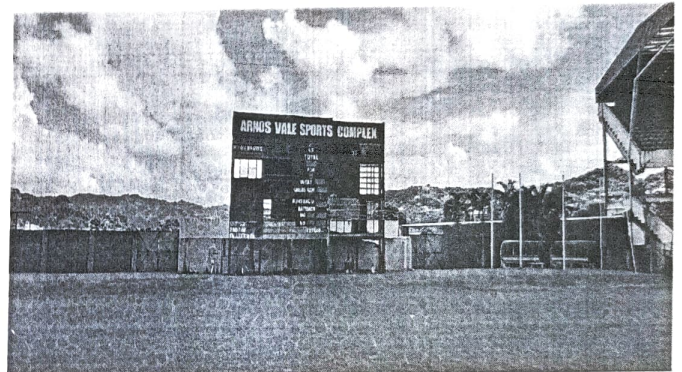
Section V is the specification sheet which is a separate pdf on the procurement.gov.vc website named "Specifications - Replay Screen". The link is provided below:

2. Table on page #25 – Location of Replay Screen

The desired placement of the one (1) replay screen is the support structure of the current scoreboard to be rehabilitated. See below screenshot "Screenshot 2023-08-31 093207.png".
Page 24 of the bidding document "Section IV: Schedule of Requirements" has the instructions for filling the table on page 25.

3. Resolution discrepancy between the module, cabinets (6mm) and the full screen resolution (10mm)

The specification should be revised as follows:

It should be 6mm fixed pixel pitch throughout the document. Wherever there is a reference to P10 it should be P6. The screen size and total pixels were based on the module size of 320mm x 160mm and the P10 configuration. This should be corrected so that 3.5 Total Pixels 1920 x 1280 = 2,457,600 pixels.

4. Cabinet/module sizes

If a different module size than that which is specified is used, the closest to the dimensions stated would be considered, therefore slightly larger size is acceptable.

5. Access to LED Panel

Access to the LED cabinet should be from the rear for installation and maintenance purposes.
