The Government of Saint Vincent and the Grenadines has received funding toward the cost of the Kingstown Revitalization Project, and intends to apply part of the proceeds for Consulting Services.

The consulting services ("the Services") include the formulation of a Master Plan and Urban Design with a multidisciplinary approach to provide integral and context-based solutions for Kingstown's urban challenges while improving the socio-economic activity of the city. The Government of St. Vincent and the Grenadines is expected to achieve this goal through the accomplishment of the following objectives:

- (i) The development in a collaborative and inclusive manner with all stakeholders, of a vision that will help guide the decision-making process;
- (ii) Generating an urban project that improves the quality of life of its residents and attracts private investment to the city centre to increase employment generation;
- (iii) Based on this vision, the development of an exemplary world class SIDS urban revitalization and resilience master plan for the city

The expected duration of the consultancy is sixty - six (66) weeks.

have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:

Qualification & Experience

- (i) The Consultants shall have a minimum of twenty-five (25) years' experience in master planning and urban design.
- (ii) The Consultants shall have creditable experience in developing climate adapted urban designs and/or projects for tropical located small towns and/or cities during the last eight (8) years.
- (iii) The Consultants should have qualified professional staff inclusive of the following: Urban Planner, Urban Economist, Urban Designer and Financial Risks and Investment Analyst.

A Consultant will be selected in accordance with the Quality and Cost Based (QCBS) selection method set out in the Public Procurement Regulations (2019) of Saint Vincent and the Grenadines.
