The position of Project Manager is a contracted full – time position based at the Ministry of Urban Development. The contract will be for twenty – four (24) months in the first instance, and will be subject to renewal based on the Consultant's satisfactory performance and work availability.

• Experience in writing Terms of Reference and Design Briefs for consultants

• Demonstrated experience in projects undertaken within in the Eastern Caribbean would be

an asset.

• Knowledgeable in areas of project life cycle, procurement management and construction

management.

A Consultant will be selected in accordance with the Individual Consultant Selection method set

out in the Public Procurement Regulations (2019) of Saint Vincent and the Grenadines.
