The ***Government of Saint Vincent and the Grenadines*** has received financing from the World Bank toward the cost of the ***OECS Regional Health Project*** and intends to apply part of the proceeds toward payments under the contract for ***Construction of a new Public Health Laboratory Building***.
2. The ***Economic Planning Division, within the Ministry of Finance, Economic Planning and Information Technology***, now invites sealed Bids from eligible Bidders for ***the construction of three floors building measuring 1352 square metres. The building will provide accommodation for new laboratories, offices and other ancillary areas. The building will utilize a dual structural system comprising of structural beam and column frames and structural walls surrounding the elevator and staircase. The expected duration of the work is fifteen (15) months. The site is located adjacent to the Milton Cato Memorial Hospital in Kingstown.***
3. Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers ***September 2023*** ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
