The **Economic Planning Division** now invites sealed Bids from eligible Bidders for the *construction of a single-storey building in reinforced concrete including finishes, electrical, plumbing, HVAC, Fire prevention, telecommunication, security, CCTV and external works. Access and exterior works include pavement and drainage works. The expected duration of the work nine (9) months*
3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" **February 2025** ("Procurement Regulations"), and is open to all Bidders as defined in the Procurement Regulations.

Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on July 3, 2025.
