The Government of Saint Vincent and the Grenadines (GoSVG) has received financing from the World Bank toward the cost of the **Unleashing the Blue Economy of the Caribbean (UBEC) Project – 3.0 Contingency Emergency Response Component (CERC)** and intends to apply part of the proceeds toward payments under the contract for the purchase of refrigerators, for seed storage and the Animal Health Division, in support of the SVG Food Insecurity Project.
